State Aid Overview: 2023-2024 Governor Proposed Budget

- Overall State Aid has increased over \$1.2 Million since 2018-2019
- Foundation Aid: Currently 67.4% of State Aid. 2018-19 it was 77.3%
- Building Aid: Increased Due to Capital Project, Reduction from 22-23 due to Converting from Ban to Bond
- Excess Cost Aid Increasing
- Transportation Has Been Consistent
- BOCES Aid: Starting to Increase
 - Has been consistent in prior years
 - Increasing purchases through BOCES for equipment 43.7% aid ratio



Tax Cap

- Tax Cap Maximum Increase of 3.48% Filed Tax Cap with Office Of State Comptroller – March 1st
 - Total Exclusions of \$545,352
 - Total Levy \$10,340,331

• Tax Cap Increased Revenue \$347,646

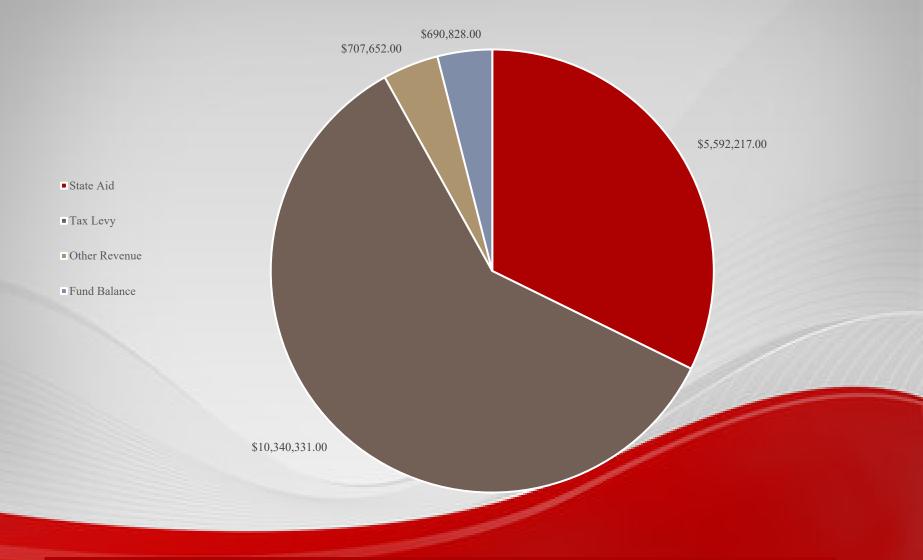


Revenue Projections
